TOURNAMENT RULES

ALL TWENTY - 20 CUP RULES ENFORCED BY ICC / PCB WILL BE FOLLOWED EXCEPT HEREUNDER

- 1- MATCHES WILL COMMENCE AT 2:30 P.M. SHARP, REPORTING TIME OF THE TEAMS AT THE GROUND WILL BE 2:00 P.M. TOSS WILL TAKE PLACE AT 2:15 P.M. TEAMS NOT ADHERING TO THE ABOVE MENTIONED TIMINGS WILL LOSE ONE OVER FOR EVERY 5 MINUTES FROM STARTING TIME.
- 2- ON SUNDAY, THE MATCHES WILL BE PLAYED IN THE MORNING AND AFTERNOON SESSION. MORNING MATCHES WILL COMMENCE AT 10:00 A.M. WITH REPORTING TIME OF THE TEAMS AT THE GROUND WILL BE 9:30 A.M. TOSS WILL TAKE PLACE AT 9:45 A.M.
- 3- ALL MATCHES WILL BE LIMITED TO 20 OVERS PER INNING INCLUDING.
- 4- EACH BOWLER WILL BE PERMITTED TO BOWL A MAXIMUM OF 04 OVERS.
- 5- KITS PROVIDED BY KARACHI GYMKHANA MUST WORN DURING TOURNA-MENT MATCHES.
- 6- ANY UNFAIR PLAY OR MISBEHAVIOR ON PART OF THE TEAM COULD LAY TO DISOUALIFICATION.

7- POINTS SYSTEM

WINNING TEAM WILL GET TWO (2) POINTS

LOSING TEAM WILL GET ZERO (0) POINT

IN CASE OF A TIE OR NON-COMPLETION OF THE MATCH DUE TO ANY REASON WILL GET ONE POINT EACH. REPORTING OF THE TEAM AT THE GROUND IS

- 8- A MAXIMUM OF 05 FIELDERS CAN BE PLACED ON THE ON / LEG SIDE OF THE WICKET, AND MAXIMUM OF 06 ON OF THE OFF SIDE OF THE WICKET.
- 9- IF THERE IS ANY VIOLATION/CONTRAVENTION OF RULE NO.8 THEN IT WILL BE DECLARED A NO-BALL
- 10- ANY BALL WHICH IN THE OPINION OF THE UMPIRE IS OUT OF THE REACH OF BATSMAN SHALL BE DECLARED A WIDE BALL, ONLY ONE BALL BETWEEN HEAD & SHOULDER OF STRIKER IS ALLOWED IN AN OVER.
- 11- USAGE OF MOBILE PHONE AND MEETING OF GUESTS DURING THE MATCH-ES IS STRICTLY NOT ALLOWED.
- 12- THIS IS AN OPEN TOURNAMENT ANY PLAYER PARTICIPATING ON BEHALF OF ANY TEAM IN THE TOURNAMENT WILL NOT BE PERMITTED TO PLAY FOR ANY OTHER PARTICIPATING TEAM. (PCB TOURNAMENT EVALUATION COMMITTEE ORDER WILL BE APPLIED).
- 13- ALL PARTICIPATING TEAMS ARE REQUIRED TO FOLLOW THE FOLLOW-ING PCB TOURNAMENT EVALUATION COMMITTEE ORDER.
- (A) WITHOUT THE PERMISSION OF PCB NO REGION AND DEPARTMENT AFFILIATED WITH PCB SHALL PARTICIPATE IN THE SAID TOURNAMENT
- (B) CONTRACT / REGISTER PLAYERS WITH PCB WHO WISH TO TAKE PART IN THE SAID TOURNAMENT MUST PERSONALLY APPLY FOR AN NOC FROM THE BOARD AND SUBJECT TO THE BOARD'S APPROVAL THE PLAYER MAY PARTICI-PATE IN THE SAID TOURNAMENT.
- 14- THIS IS AN OPEN TOURNAMENT ANY PLAYER PARTICIPATING ON BEHALF OF ANY TEAM IN THE TOURNAMENT WILL NOT BE PERMITTED TO PLAY FOR ANY OTHER PARTICIPATING TEAM.

15- IN CASE OF TIE **DURING LEAGUE MATCHES**

(A) IN CASE OF A TIE OR NON-COMPLETION OF THE MATCH, DUE TO RAIN, BAD LIGHT, FORCE MAJEURE ANY OTHER REASON IN THE LEAGUE MATCHES BOTH TEAMS WOULD BE AWARDED ONE POINT EACH.

(B) IF TEAMS END UP WITH EQUAL POINTS THEN, NET RUN RATE WILL BE APPLIED TO DETERMINE NO.1 & NO.2 OF THE GROUP WHICH WILL BE ACCOR-DANCE TO PCB AND ICC REGULATIONS.

DURING KNOCK OUT MATCHES

AT THE KNOCK OUT STAGE OF THE TOURNAMENT IN CASE OF A TIE, IF RUNS SCORED BY BOTH THE TEAMS ARE THE SAME THEN THE FOLLOWING PROCEDURE OF ONE OVER PER SIDE ELIMINATOR WILL BE APPLIED AS PER ICC RULES:

- (A) SUBJECT TO WEATHER CONDITIONS THE ONE OVER PER SIDE ELIMINA-TOR WILL TAKE PLACE ON THE SCHEDULED DAY OF THE MATCH AT A TIME TO BE DETERMINED BY THE MATCH REFEREE / UMPIRES. IN NORMAL CIRCUM-STANCES IT SHALL COMMENCE 5 MINUTES AFTER THE CONCLUSION OF THE
- (B) THE ONE OVER PER SIDE ELIMINATOR WILL TAKE PLACE ON THE PITCH ALLOCATED FOR THE MATCH (THE DESIGNATED PITCH) UNLESS OTHERWISE DETERMINED BY THE UMPIRES IN CONSULTATION WITH THE GROUND AUTHORITY AND THE REFEREE (IF APPOINTED)
- (C) PRIOR TO THE COMMENCEMENT OF THE ONE OVER PER SIDE ELIMINATOR EACH TEAM ELECTS THREE BATSMAN AND ONE BOWLER.
- (D) THE NOMINATED PLAYERS ARE GIVEN IN WRITING TO THE UMPIRES.
- (E) THE UMPIRES SHALL STAND AT THE SAME END AS THAT IN WHICH THEY FINISH THE MATCH.
- (F) THE UMPIRES SHALL CHOOSE WHICH END TO BOWL AND BOTH TEAMS WILL BOWL FROM THE SAME END.
- (G) EACH TEAMS OVER IS PLAYED WITH THE SAME FIELDING RESTRICTION AS THOSE THAT ARE IN PLACE FOR THE LAST OVER OF A NORMAL T-20 INTERNA-TIONAL MATCH.
- (H) THE BATTING SECOND IN THE MATCH WILL BAT FIRST IN THE ONE OVER ELIMINATOR.
- (I) THE SAME BALL (OR A BALL OF A SIMILAR AGE IF THE ORIGINAL BALL IS OUT OF SHAPE) AS USED AT THE END OF THE TEAM INNINGS SHALL BE USED FOR THE "EXTRA" OVER.
- (I) THE LOSS OF TWO WICKETS IN THE OVER ENDS THE TEAMS ONE OVER INNINGS.
- (K) IN THE EVENT OF THE TEAMS HAVING THE SAME SCORE AFTER THE ONE OVER PER SIDE ELIMINATOR HAS BEEN COMPLETED, THE TEAM THAT HIT THE MOST NUMBER OF SIXES COMBINED FROM ITS TWO INNINGS IN BOTH THE MAIN MATCH AND THE ONE OVER PER SIDE FLIMINATOR SHALL BE THE WINNER
- (L) IF THE NUMBER OF SIXES HIT BY BOTH THE TEAM IS EQUAL, THE TEAM THAT HIT THE MOST NUMBER OF BOUNDARIES (FOUR AND SIXES) IN THE 'ELIMINATOR' WILL BE DECLARED THE WINNER.
- 16- BEST PLAYERS WILL BE DETERMINED ON LEAGUE MATCHES.
- 17- THE DECISION OF THE TECHNICAL COMMITTEE IS FINAL AND BINDING ON ALL THE PARTICIPATING TEAMS AND THE SAME WOULD NOT BE CHALLENGED IN ANY COURT OF LAW.
- 18- THE TECHNICAL COMMITTEE OF THE RAMAZAN FESTIVAL RESERVES THE RIGHT TO AMEND / ALTER ANY OF THE ABOVE NOTED RULES OF THE TOURNAMENT. THE DECISION OF THE SAID COMMITTEE WILL BE BINDING AND FINAL


